Connections to different cellular towers and cellular data network load balancing could change how we would connect to the state. This project should have been planned and executed in a more collaborative manner so we could avoid this crisis. Here are some of the problems that, I see, could occur for us without near live connectivity:

- We will not be able to process any paper ballots from Monday until late Wednesday morning. We will likely receive 100k+ ballots on Monday and Tuesday and we cannot process any of them until we manually sync about 250 laptops Wednesday morning.
- The chance of someone voting twice goes up a lot especially voting twice at two different Vote Centers.
- We will need to alter and/or add release days to our schedule because of the ballot processing delay.
- Reduced number of paper ballots decks involved in the audit.

Good afternoon, Mark.

We understand your concerns. If any of us had advanced notice on this, we would have planned it out ahead of time. This is all a result of activity that the CISO's office has noticed recently and doesn't feel like we can/should ignore. As I mentioned to you on the phone yesterday, the CISO has assured me of the following:

- This should be seamless to most users within the state.
- Most of the IP addresses should already be open. Anybody currently using the state's network or Verizon hot spots are open, as well as any known VISTA Local users.
- If they see safe traffic hitting the network, they will open it immediately, so it shouldn't impact any of your ballot processing operations.
- I did make him aware of your usage of hot spots, and he indicated they can deal with that easily.
- As it stands now, they are monitoring the network closely and will only take the actions they deem necessary to secure our election.
- DTS will have additional staff on hand Monday and Tuesday to take care of any IP addresses that need to be opened. Your staff can call or email me (email is preferred since I only have one phone line), and I'll work directly with the security staff to get them opened immediately. My email is [markm@utah.gov](mailto:markm@utah.gov) and my cell number is [REDACTED]

I reviewed this all with the CISO just now. He assured me again, that they will only take actions deemed necessary. So we may notice nothing at all. If you or your staff do have trouble connecting with VISTA Local, please email me at [markm@utah.gov](mailto:markm@utah.gov). I have the CISO's assurance that they can open any type of connection very quickly.



Hello Megan,

Thank you for your letter. Please share this response with the other candidates who signed the letter.

I am responding on behalf of Governor Herbert, Lt. Governor Cox, and myself. We understand this is a difficult time, but we do not have the authority to extend the deadlines for signature gathering, or to lower the amount of signatures needed for each office. While a Federal District Court judge did lower the threshold for one candidate, he made it clear that his ruling did not apply to other candidates. As today is the deadline for our office to certify names for the primary election ballot there is also no time for additional signature gathering or signature verification.

I would also like to note that the majority of the candidates who signed the letter would have participated in state conventions, and would not have had the time constraints you referenced in relation to other candidates. I should also point out that some of the candidates don't appear to have declared an intent to gather signatures, or they selected the convention only route when declaring candidacy. Even if we did have some authority to move deadlines or change thresholds it does not seem that would help all of the candidates who signed the letter.

Dear Governor Herbert, Lt. Governor Cox, Attorney General Sean Reyes, and Director of Elections Justin Lee:

Over the last month, our community has slowed the spread of this disease by adhering to recommendations from government officials and public health experts to social distance and shelter in place. We've been heartened by the State's adaptability and efforts, including but not limited to establishing economic and health task forces, increasing access to COVID-19 testing and PPE, working to protect vulnerable populations, leveraging Utah's tech sector to drive innovative solutions, and more.

The evidence is clear, COVID-19 threatens the lives of Utahns and millions of people throughout the world. Its impacts are far reaching and touch almost every aspect of society—public health, economy, livelihoods, and even our local elections. It's a global problem that requires global cooperation and we're grateful to have leadership with the willingness to face these unprecedented challenges head on.

While we recognize the efforts made, we the undersigned candidates believe the State has fallen short in protecting the integrity of our local elections. In order for a candidate to participate in Utah's June primary, they may collect signatures individually and/or use volunteers or paid

professionals. The Supreme Court has acknowledged this right of collecting petition signatures as a viable path to getting on the ballot and that right should be protected. For weeks we reached out expressing concern, but adequate adjustments were never made.

As a result, the only option we had was to go the caucus/convention route where a small pool of delegates selected nominees. It is worth noting non-incumbent (and non-incumbent endorsed) candidates faced significant barriers given party decisions to use 2018 delegates as their base. We entered a process that was not neutral, as many openly indicated they had their minds made up before final candidates had even been announced. However, to be fair, most know what they are getting into when they select this path. Our issue is not with our opponents, nor the delegates. However, it is important for us to share our experiences as they illustrate the barriers we encountered as candidates. Additional challenges also existed given the order that made large gatherings illegal. Caucus night was cancelled and conventions had to be coordinated remotely.

After making a good faith effort to work within the parameters of the outlined process, we have determined there was no viable or fair path for us to get on the 2020 ballot. As such, we the undersigned candidates are writing to urge Governor Herbert and the Utah State Legislature to extend the deadline to submit nomination signatures. We also request that provisions be made allowing for digital signatures and a reduction in threshold. States and courts across the country have made these accommodations and we're calling on our government to do the same.

Respectfully, we do not feel the Executive Order issued by Governor Herbert on March 26 was sufficient and request the points below be taken into consideration:

- The Executive Order made helpful provisions that allowed electronic transfer. However, it still required obtaining physical signatures, involving multiple steps and printing resources.
- The Executive Order did not take into account time lapsed or signature gathering barriers. Fundamentally signature gathering candidates were asked to put the health and safety of our community first. Based off direction to social distance and "stay home" from our government, we were not able to move forward during the signature gathering period indicated in March. Going door-to-door, exchanging pens and engaging in close face-to-face conversations would have endangered front-line volunteers and citizens (some elderly). It put candidates who had invested time and resources into campaigning in difficult positions. It's important to understand this was during a time when mask availability and testing was severely limited. Door open rates also dropped significantly due to government warnings, global and national news, as well as high profile local cases including Ben McAdams and Utah Jazz players. Many of us expressed these concerns to elections officials, but there was no attempt to make adjustments until the last minute.
- The Executive Order did not consider early races or provide an adequate time frame adjustment. For example, the Democrat Salt Lake County primary was held on April 11.

With the rules stating signatures were due two weeks prior to Convention, that gave Democrat Salt Lake County candidates just two days to attempt gathering electronic transfer signatures. Republican Salt Lake County Democrats got an additional week.

- The Executive Order was not structured to scale. Utah has by far one of the strictest signature gathering requirements in the nation in terms of threshold. For Governor and Congressional races, it is also challenging due to the landmass and number of driving miles needed to get from place to place. We're seeing similar federal cases pop in other places that have heavy signature requirements (although mostly due to population size).
- The Executive Order did not take into account unaffiliated voters. In districts like HD46, over 37% of voters are unaffiliated and are not represented by the convention system. Similarly, Utah has one of the highest percentages of unaffiliated voters in the country with 33%. Without a viable path for non-convention candidates, over a third of the voters in this state will be disenfranchised.

However, it is important for us to share our experiences as they illustrate the barriers we encountered as candidates. Additional challenges also existed given the order that made large gatherings illegal. Caucus night was cancelled and conventions had to be coordinated remotely.

After making a good faith effort to work within the parameters of the outlined process, we have determined there was no viable or fair path for us to get on the 2020 ballot. As such, we the undersigned candidates are writing to urge Governor Herbert and the Utah State Legislature to extend the deadline to submit nomination signatures. We also request that provisions be made allowing for digital signatures and a reduction in threshold. States and courts across the country have made these accommodations and we're calling on our government to do the same.

Respectfully, we do not feel the Executive Order issued by Governor Herbert on March 26 was sufficient and request the points below be taken into consideration:

- The Executive Order made helpful provisions that allowed electronic transfer. However, it still required obtaining physical signatures, involving multiple steps and printing resources.
- The Executive Order did not take into account time lapsed or signature gathering barriers. Fundamentally signature gathering candidates were asked to put the health and safety of our community first. Based off direction to social distance and "stay home" from our government, we were not able to move forward during the signature gathering period indicated in March. Going door-to-door, exchanging pens and engaging in close face-to-face conversations would have endangered front-line volunteers and citizens (some elderly). It put candidates who had invested time and resources into campaigning in difficult positions. It's important to understand this was during a time when mask availability and testing was severely limited. Door open rates also dropped significantly due to government warnings, global and national news, as well as high profile local cases including Ben McAdams, Luz Escamilla, and Utah Jazz players. Many of us expressed these concerns to elections officials, but there was no attempt to make adjustments until the last minute.
- The Executive Order did not consider early races or provide an adequate time frame adjustment. For example, the Democrat Salt Lake County primary was held on April 11.

With the rules stating signatures were due two weeks prior to Convention, that gave Democrat Salt Lake County candidates just two days to attempt gathering electronic transfer signatures. Republican Salt Lake County Democrats got an additional week.

- The Executive Order was not structured to scale. Utah has by far one of the strictest signature gathering requirements in the nation in terms of threshold. For Governor and Congressional races, it is also challenging due to the landmass and number of driving miles needed to get from place to place. We're seeing similar federal cases pop in other places that have heavy signature requirements (although mostly due to population size).
- The Executive Order did not take into account unaffiliated voters. In districts like HD46, over 37% of voters are unaffiliated and are not represented by the convention system. Similarly, Utah has one of the highest percentages of unaffiliated voters in the country with 33%. Without a viable path for non-convention candidates, over a third of the voters in this state will be disenfranchised.

Dear Lt. Governor Cox:

In 2014, at the request of the White City Water Improvement District (hereafter "WCWID") and other local districts, the Utah Legislature passed H.B. 415, sponsored by Rep. Steve Eliason, to amend the Utah Code to allow a local district, such as WCWID, to change its election cycle from the Municipal Election Cycle occurring in odd number years to the General Election Cycle taking place in even number years. See Utah Code §17B-1-306(13):

- (13)(a) As used in this Subsection (13), "board" means:
- (i) a local district board; or
  - (ii) the administrative control board of a special service district that has elected members on the board.
- (b) A board may hold elections for membership on the board at a regular general election instead of a municipal general election if the board submits an application to the lieutenant governor that:
- (i) requests permission to hold elections for membership on the board at a regular general election instead of a municipal general election; and
  - (ii) indicates that holding elections at the time of the regular general election is beneficial, based on potential cost savings, a potential increase in voter turnout, or another material reason.
- (c) Upon receipt of an application described in Subsection (13)(b), the lieutenant governor may approve the application if the lieutenant governor concludes that holding the elections at the regular general election is beneficial based on the criteria described in Subsection (13)(b)(ii).
- (d) If the lieutenant governor approves a board's application described in this section:
- (i) all future elections for membership on the board shall be held at the time of the regular general election; and

(ii) the board may not hold elections at the time of a municipal general election unless the board receives permission from the lieutenant governor to hold all future elections for membership on the board at a municipal general election instead of a regular general election, under the same procedure, and by applying the same criteria, described in this Subsection (13).

*Emphasis added.* See also, Utah Code §17B-1-303(8): "The lieutenant governor may extend the term of an elected district board member by one year in order to compensate for a change in the election year under Subsection 17B-1-306(13)." [It should be noted SB 33 passed this year will renumber 17B-1-306 (13) to 17B-1-306 (14).]

This letter, together with the attached Resolution 2019-01-001, adopted by WCWID's Board of Trustees on January 16, 2019, constitutes WCWID's formal application, under subpart (b) of Section 13 of Utah Code 17-1-306, to move its election from this coming 2019 Municipal Election Cycle to next year's Regular Election Cycle<sup>1</sup>. In that regard, the elected Board of Trustees of WCWID has determined it is beneficial to WCWID and its residents to move the election cycle.

First, it is probable that WCWID will have a greater voter turnout in a General Election Cycle than in a Municipal Election Cycle. This is especially true this coming year which is a Presidential and Governor election cycle.

Second, while the cost for running WCWID's election during the Regular Election Cycle is unknown at this time, discussions with the Salt Lake County Clerk, have led WCWID to conclude that either the election costs for running the election during the general cycle will be less than that of the municipal cycle, due economies of scale, or, at worse, will be similar.

Third, and this counts as "another material reason" under the statute, WCWID provides water service to residents of Sandy City ("Sandy"), unincorporated Salt Lake County ("County") and White City Metro Township ("Metro Township")(which was incorporated in 2017). As presently scheduled, both Sandy City and the Metro Township have elections this year. Adding WCWID election to the same ballot will lead to confusion and will result in Metro Township residents mixing up the two ballots. In addition, WCWID residents living within the County will not participate at the same rate in the Municipal Election Cycle and in the Regular Election Cycle<sup>2</sup>. In addition, WCWID is striving to separate itself, in the eyes of all its residents that it is

<sup>1</sup> Since adoption of the Resolution I have had discussions with the Salt Lake County Clerk on what cost implications there could be by changing to the Regular Election Cycle. Based on those discussions, WCWID and the Clerk have agreed that if there is an increase in cost, and it is just speculation at this time, WCWID will either cover the cost or will run its own election by mail in 2020.

<sup>2</sup> In 2017 WCWID approached Deputy Director Justin Lee about moving the election cycles because, in part, of the recent 2017 Metro Township incorporation. At that time, he asked for clarification how moving the election "will avoid confusion between township and the district being on the same ballot." At the time, it was speculation if residents would be confused between the two entities. Two years later, we know that some residents are confused and it is not unusual for residents to contact the district on metro township issues and vice-versa.

independent and that it provides water service without regard to where they live or in what political jurisdiction - Sandy City, County or White City Metro Township<sup>3</sup>. See attached map of WCWID, Attachment "B."

WCWID appreciates your support of the independent local districts of the State and your input back in 2014 when H.B 415 was being drafted and considered. I am available anytime to discuss this matter with you and I will be happy to provide you or Director Lee with additional information as needed<sup>4</sup>. Obviously, the earlier we can receive your decision the better so we can inform the Salt Lake County Clerk with whom we have contracted for election services.

WHEREAS, its residents include residents of Sandy City, unincorporated Salt Lake County and the White City Metro Township, and

WHEREAS, in 2014, at the request of WCWID, the Utah Legislature passed H.B. 415 to amend the Utah Code to allow a local district, such as WCWID, to apply to the Lieutenant Governor, to switch its Board of Trustees election to the Regular General Election instead of the Municipal General Election, *see* Utah Code 17B-1-303(8), 17B-1-306(13), and

WHEREAS, WCWID believes it would be in the best interest of all of its residents to switch the Board of Trustees election to the Regular General Election due to cost savings, probable increase in voter turnout and other material reasons including the avoidance of voter confusion between election ballots between WCWID and the Metro Township, both of whom share the "White City" name, and to encourage greater participation of unincorporated county voters, and

WHEREAS, under Utah Code 17B-1-306(13)(c) the Lieutenant Governor may grant permission to switch a Board of Trustees election to the Regular General Election cycle instead of the Municipal General Election cycle if there is potential cost savings or potential increased voter turnout or another material reason.


NOW, THEREFORE, BASED ON THE REASONS SET FORTH ABOVE, IT IS HEREBY RESOLVED, by the White City Water Improvement District that:

(1) Application be made to the Lieutenant Governor, under Utah Code 17B-1-306(13) to hold the election for the White City Water Improvement Board of Trustees, presently scheduled for this year's municipal general election, to the Regular General Election, scheduled in 2020.

(2) Staff is instructed and authorized to work with the Lieutenant Governor's office and Salt Lake County Clerk's office to quickly transition the change in the WCWID Board of Trustee election cycle so notice of the same might be provided to the District's residents living in Sandy City, unincorporated Salt Lake County and White City Metro Township, which notice shall include language that the change in WCWID's election will not affect nor change the elections for officers in Sandy City or the White City Metro Township.





A \$300 cleaning deposit will need to be paid up front, and cleaning, staff, electrical and other expenses will be billed after at cost.

The reason for this is we are not actually state nor county owned. We are a non-profit company. You will also need to be able to provide insurance that meets our requirements, which is 1 million per occurrence and 3 million general aggregate.


