Essentially this bill makes the deadline to designate or change party affiliation March 31st. Voters new to the state can join a party at any time. I do not think it allows unaffiliated voters to vote in a closed primary – and the language is awful.

Help me out here, but this language makes no sense to me and I think it should just be stricken from the bill, or modified to apply only to a presidential primary that is not in conjunction with the regular primary election, as there is absolutely no intention of letting an unaffiliated voter join a party after April 1 and vote in a primary. Since that is the case, I see no need for any of this confusing language to exist.

20A-2-107.5. Designating or changing party affiliation -- Regular primary election and presidential primary election.

(1) At any regular primary election or presidential primary election:

(a) each county clerk shall provide change of party affiliation forms to the poll workers for each voting precinct within the county; [and]Affiliation forms at the polls

(b) [any] except as provided in Subsection (1)(c), a registered voter who is classified as "unaffiliated" may affiliate with a political party by completing the form and giving it to the poll worker[.]; and Unaffiliated voters can join a party by filling out form except between April 1 and the Primary

I would really like to clean this language up to clearly state what is and is not allowed. My understanding is that the intent is to allow unaffiliated voters to join a party at any time and be able to vote, unless at any point after April 1 they have joined a party and then unaffiliated (party hopping).

My proposed language would basically put a freeze on party switch parties or becoming unaffiliated after April 1. This takes away any potential administrative issues with having to track whether an unaffiliated voter was a member of a party after April 1. Please provide immediate feedback so I can get this language to the sponsor ASAP – I'm not sure he is willing to change the language, but I would like to try.

(1) At any regular primary election or presidential primary election:

- (a) a registered voter who is classified as "unaffiliated" may affiliate with a political party by completing a party affiliation or registration form, except as provided in Subsection (1)(b); and
- (b) the party affiliation for a voter who changes political party, or becomes unaffiliated from a political party, any time between April 1 and the date of the regular primary election takes effect on the day after the regular primary canvass.

(2) An unaffiliated voter who affiliates with a political party as provided in Subsection (1) may vote in that party's primary election.

We should oppose this bill on the grounds that we need to evaluate this past election and identify areas that can be improved going forward. If after we make our recommendations the need is there for legislative action, then legislation can go forward from there.

Weber County had 9 vote centers and 100,969 active registered voters. Legislating a number of polling places in this manner will not solve long lines at polling places. What I feel like we need to do is take a long hard look processes, find efficiencies, and implement changes – policy or legislative – that are driven by logic and data. Approaching it in this manner will help us find ways to effectively process voters in every election.

There are few factors that are not even being considered by this bill:

1. Standing in line was optional in VBM counties. All active voters were mailed a ballot and provided with several options to return it including through the mail, in drop boxes before Election Day, and drop boxes on Election Day.
2. This was the first presidential election where many counties voted by mail.
 - a. Long lines were not unique to counties that voted by mail
 - b. Not all counties that voted by mail had long lines
3. Fifty-two percent of our ballots we cast on Monday and Tuesday. This was an unusual year where voters were reluctant to vote, and as a result held onto their ballot until the last minute or chose to come in and vote in-person. That being said, nearly 85 percent of our voters did not wait in any sort of a line.
4. In 2008 almost everyone in the entire state had huge early voting lines. As a result we all made adjustments and early voting lines have been reasonably short ever since. We see a problem and we fix it. We see a problem this year and we will fix it.

I am attaching a graph that shows the processing resources we had available to us on Election Day. The area shaded in blue represents the amount of processing time that was taken up by provisional voters and the orange area is what we had left over to process the regular voters. Provisionals consumed 58 percent of our poll worker's time, not properly anticipating the amount of time for provisionals was a factor in us having lines. Unfortunately I don't have good data on how long our lines were, but having one more polling place as mandated by this bill will not solve my issue with having lines.

Here is my main thought: We have formed a committee to study the provisional voting process. With the committee I would like to do a full-blown program evaluation report that can be used for years to come as a guide to provisional voting. With the group we have, I think we can do a comprehensive report that can be presented at the interim. Some of the areas I would like to look into are:

- 1) Survey voters that voted provisionally, get input from them and find out why they hadn't registered or updated their information
- 2) Survey or interview poll workers to gain input from them on what works, what could be done better, and identify new ways things could be done
- 3) Evaluate our current process to determine its strengths and weaknesses and to identify technology that could be used to more efficiently check voters in
- 4) Evaluate our current registration processes



Dear Fellow Clerks,

As we have discussed in our conference calls and meetings there is some concern from our political parties as to how they will process voters at the caucus meetings who have classified their record private. Regardless of our efforts to educate the parties on how to prevent issues on caucus night, they continue to use this narrative in their efforts to remove voter privacy (see the link below). This has the potential of creating an administrative headache for the caucus organizers, and a frustrating experience for attendees.

While the discussion continues with the Legislature regarding SB83, we felt it very important that regardless of what happens with the bill, our priority should be to ensure that the caucus organizers have the information and resources to be successful.

In an effort to help provide support for a successful caucus night for all parties, we have reached out to our County Chairs to offer assistance. We have provided them with a copy of the attached poster, which notifies "Private Voters" of steps they need to take to provide evidence of registration and party affiliation. We have provided instructions to our party chairs on how to use Vote.Utah.gov to find "Private Voters" when they don't appear on the list.

If our political parties will use this resource they will be able to find and verify the registration status of the private voters. This will help move the check-in process forward and avoid the necessity of having these voters complete an unnecessary voter registration form (which then we will have to deal with). Because the state parties seem disinterested in the caucus night solutions provided, I would encourage each Clerk to reach out to their local party chairs and communicate this information to them.



Some comments from clerks and from Justin Lee at the LG's office. Would you mind giving Justin a call and going through this? His # is 801.538.1129

Justin: I disagree with his reading on that. It distinguishes a candidate from a person running for county or municipal office. It says "candidate **or** person seeking a municipal or county office." A candidate remains a state level office, while a person running for local office is different. This distinction is important for laws relating to PACs and Corporations. If we removed that there would be widespread ramifications - they inform several other code sections.

Clerks: Line 495 establishes a limit of 100.00 cash contribution. It does not specify for which office, I believe this may leave it open to assume that this is applicable for all races, including County races. Other than that I believe only impacts offices listed in lines 418-425 which are repeated a couple of times.

The \$100 cash contribution maximum also applies to PACs, Corporations and labor organizations. I see where it could apply to County races but it's ambiguous at best. It needs to be clarified as I believe a County Elected Official could receive unlimited "non-cash" contributions – no maximums specified for folks like us.

You are correct. Because of how it is listed, it could be implied that it applies to everyone. I would recommend this be clarified to identify for whom these restrictions apply. Other than this one line though, I don't believe it has any impact on the counties.

SB114 – Election Law Amendments

As County Clerks have the statutory duty to serve as the election officers for each county and as the election administrator for all federal state and county elections we have reviewed the proposals made in SB114 and provide this information for consideration.

From the County's point of view there are two primary concerns with this proposed bill

1. An administratively impossible timeline for election officials to meet.

The primary election will be held on June 26, 2018, a county would complete the canvass of the primary election on July 11, 2018 and the state would complete their canvass on July 13, 2018. Ballots for a by mail runoff election will need to enter the mail system on July 24, 2018 (three weeks prior to the runoff). Under the current proposal it would provide seven (7) business days from the date of the state canvass to the date that ballots will need to be mailed to the voters.

Seven business days is not sufficient time to plan and prepare for an election. Included is a list of the minimum tasks that must be completed with their associated timeline in order to appropriately prepare for a runoff election.

Proposed Solution- Move the primary election day to the first week in June.

As currently provided for in state statute we average a 60 day preparation widow for each election. As clerks we have reviewed our procedures, associated tasks, and statutory requirements that need to be accomplished, and believe that these could be accomplished within the 53 days provided by moving the primary to the first week in June. This is the absolute minimum time we need to provide the citizens with a secure, efficient, and accurate election.

2. Lack of clarity on the financial support provided by the state for the cost of a runoff election.

Current estimate on a statewide runoff type of an election is \$2.9 million. The current draft says "within funds appropriated by the Legislature for this purpose, the lieutenant governor shall reimburse each county for the expense, as determined by the lieutenant governor, of conducting a runoff election under this section" Yet this bill does not appropriate any monies for this purpose, nor does it provide a guarantee that the amount determined by the lieutenant governor will cover the full cost incurred by a county.

Proposed Solution- Provide a method that requires the legislature to appropriate adequate funds for this purpose and a specified process that will provide a full reimbursement of county expenses for each runoff election.

Below are some considered negotiation points for SB 52 that I have worked on with the Treasurer's group. We'll discuss them on tomorrow's call.

Requested Changes to SB 52 from Treasurers Group by order of importance

- 1) Under 59-2-1802 (3) change **shall** defer tax to **may** defer tax (line 44)
- 2) The applicant applying would be delinquent for property taxes for multiple years
- 3) Demonstration of a hardship by the applicant by having income (using same calculation as used under the Circuit Breaker Program) of less than 1.5 times the Circuit Breaker income level and the assessed value of the home would be less than the median assessed value of the County of residence
- 4) The applicant must be 75 years or older
- 5) The interest rate charged would be at a rate that would deter the applicant from using the deferral of property tax as an investment tool. We feel the current deferral rate of 0.25% invites abuse of the program

We had some other concerns relating to trusts and primary residence as of January 1 but think the bill addresses those issues.

WHAT IS DOMESTIC VIOLENCE?

 - 1 in 3 women and 1 in 4 men have experienced some form of physical violence by an intimate partner. This includes a range of behaviors and in some cases might not be considered “domestic violence”.³
 - 1 in 7 women and 1 in 25 men have been injured by an intimate partner.⁴
 - 1 in 10 women have been raped by an intimate partner. Data is unavailable on male victims.⁵
 - 1 in 7 women and 1 in 18 men have been stalked. Stalking causes the target to fear she/he/they or someone close to her/him/them will be harmed or killed.⁶
- On a typical day, domestic violence hotlines nationwide receive over 20,000 calls.⁷
- An abuser's access to a firearm increases the risk of intimate partner femicide by 400%.⁸
- Intimate partner violence accounts for 15% of all violent crime.⁹
- Intimate partner violence is most common against women between the ages of 18-24.¹⁰
- 19% of intimate partner violence involves a weapon.¹¹

WHY IT MATTERS

Domestic violence is prevalent in every community, and affects all people regardless of age, socio-economic status, sexual orientation, gender, race, religion, or nationality. Physical violence is often accompanied by emotionally abusive and controlling behavior as part of a much larger, systematic pattern of dominance and control. Domestic violence can result in physical injury, psychological trauma, and even death. The devastating consequences of domestic violence can cross generations and last a lifetime.

SEXUAL ASSAULT

- 1 in 5 women and 1 in 59 men in the United States is raped during his/her lifetime.¹²
- 9.4% of women in the United States experience intimate partner sexual assault in their lifetimes.¹³

STALKING

- 19.3 million women and 5.1 million men in the United States have been stalked.¹⁴
- 66.2% of female stalking victims reported stalking by a current or former intimate partner.¹⁵

Access To and Use Of Voter Registration Lists

Overview



This page provides 50-state information on access to voter lists. States have varied requirements on who is eligible to request a list of voters, what information the list contains, what information is kept confidential, and how information contained in voter lists may be used. Many states also have specific programs to keep all voter information confidential for certain classes of voters.

The availability of voter lists for campaign purposes is longstanding; candidates benefit from knowing who their party's voters are. Statutes govern the details. Legislators who are interested in expanding or restricting access to voter information may want to consider the following questions:

- Who should have the access? Only political parties and candidates, the general public, academics, others?
- What information will not be provided when voter lists are distributed? Date of birth, driver's license numbers, other identifying information?
- What provisions are made to protect information for people who require address confidentiality, such as victims of domestic violence, sexual assault or stalking? (Learn more about Address Confidentiality Programs here).
- Should law enforcement agents or judges be provided with similar confidentiality?
- Is information about pre-registrants, or those under the age of 18 who are pre-registered to vote and are thus minors, be confidential?
- What process for requesting and receiving voter lists is appropriate? Some states provide a portal for access, others may run a custom extract of voter registration data depending on the information requested.
- Are there restrictions on the uses of the lists, such as that they cannot be used for commercial gain?
- Is there a mechanism for enforcing that policies are followed?
- What is an appropriate fee for voter lists? See the United States Election Project for more information.
