[(e)](e) (i) As used in this Subsection (5)(e)[(e)](e) a candidate is "unopposed" if: (A) no individual other than the candidate [receives a certification] qualifies under Subsection (3) for the regular primary election ballot of the candidate's registered political party for a particular elective office; or (B) for an office where more than one individual is to be elected or nominated, the number of candidates who [receive certification] qualify under Subsection (3) for the regular primary election of the candidate's registered political party does not exceed the total number of candidates to be elected or nominated for that office.

(ii) A candidate who is unopposed for an elective office in the regular primary election of a registered political party is nominated by the party for that office without appearing on the primary election ballot.

(6)(a) When a tie vote occurs in any primary or runoff election for any national, state, or other office that represents more than one county, the governor, lieutenant governor, and attorney general shall, at a public meeting called by the governor and in the presence of the candidates involved, select the nominee by lot cast in whatever manner the governor determines.

(b) When a tie vote occurs in any primary or runoff election for any county office, the district court judges of the district in which the county is located shall, at a public meeting called by the judges and in the presence of the candidates involved, select the nominee by lot cast in whatever manner the judges determine.

(7) The expense of providing all ballots, blanks, or other supplies to be used at any primary or runoff election provided for by this section, and all expenses necessarily incurred in the preparation for the conduct of that primary election shall be paid out of the treasury of the county or state, in the same manner as for the regular general elections.

(8) An individual may not file a declaration of candidacy for a registered political party of which the individual is not a member, except to the extent that the registered political party permits otherwise under the registered political party's bylaws. Notwithstanding any other provision of law, an election officer or filing officer shall consider an individual a member of a registered political party for purposes of determining the sufficiency of a declaration of candidacy if the individual has designated that registered political party as the individual's party membership on the individual's voter registration form at the time of filing and if the individual has not designated another registered political party as the individual's party membership on the individual's voter registration form during the past four years.

SECTION 17. SECTION 20A-9-405 IS AMENDED TO READ:

20A-9-405. Nomination petitions for regular primary elections.

(1) This section shall apply to the form and circulation of nomination petitions for regular primary elections described in Subsection 20A-9-403(3)(a).

(2) A candidate for elective office, and the agents of the candidate, may not circulate nomination petitions until the candidate has submitted a declaration of candidacy in accordance with Subsection 20A-9-202(1) or filed a declaration of candidacy as advance notification to the filing officer of an intention to circulate nomination petitions, which may be given any time after October 1st of the year prior to a regular primary election.

SECTION 18. SECTIONS 20A-9-406, 20A-9-407, 20A-9-408, 20A-9-408.5, 20A-9-409, AND 20A-9-411 ARE REPEALED.

SECTION 10. SECTION 20A-5-101 IS AMENDED TO READ:  
20A-5-101. Notice of election.

(1) On or before [November 15] October 1 in the year before each regular general election year, the lieutenant governor shall prepare and transmit a written notice to each county clerk that:

- (a) designates the offices to be filled at the next year's regular general election;
- (b) identifies the dates for filing a declaration of candidacy, and for submitting and certifying nomination petition signatures, as applicable, under Section[s] 20A-9-403[-20A-9-407, and 20A-9-408] for those offices;
- (c) includes the master ballot position list for the next year and the year following [as established under Section 20A-6-203], if available; and
- (d) contains a description of any ballot propositions to be decided by the voters that have qualified for the ballot as of that date.

SECTION 11. SECTION 20A-5-411 IS ENACTED TO READ:

20A-5-411. Candidate appearance with partisan affiliation on ballot of regular general election.

(1) Notwithstanding any other provision of law, the name of a candidate for elective office shall not appear on the ballot for a regular general election as affiliated with, endorsed by, nominated by, or otherwise associated with any political party, any political group, or any other group of any kind, unless the candidate has been nominated by a registered political party as a presidential or vice presidential candidate or unless the candidate has been nominated by a registered political party pursuant to the direct primary election or unopposed candidate processes set forth at Subsection 20A-9-403(5).

(2) Each election officer shall ensure compliance with the requirement described in Subsection (1).

SECTION 12. SECTION 20A-6-203 IS AMENDED TO READ:  
20A-6-203. Ballots for regular primary elections.

(3) Notwithstanding any other provision of law, a filing officer shall not include any marking, insignia, or other feature within the format of a regular primary election ballot that would cause a voter to view a candidate for elective office of a registered political party more positively or negatively than another candidate from that registered political party.

SECTION 13. SECTION 20A-8-103 IS AMENDED TO READ:  
20A-8-103. Petition procedures—Criminal penalty.

(2) To become a registered political party, an organization of registered voters that is not a continuing political party shall:

- (a) circulate a petition seeking registered political party status beginning no earlier than the date of the statewide canvass held after the last regular general election and ending no later than November 30 of the year before the year in which the next regular general election will be held;
- (b) file a petition with the lieutenant governor that is signed, with a holographic signature, by at least 2,000 registered voters on or before November 30 of the year in which a regular general election will be held; and
- (c) file, with the petition described in Subsection (2)(b), a document certifying:
  - (i) the identity of one or more registered political parties whose members may vote for the organization's candidates;
  - (ii) whether unaffiliated voters may vote for the organization's candidates; and
  - (iii) whether, for the next election, the organization intends to nominate the organization's candidates in accordance with the provisions of Section [20A-9-406] 20A-9-403.

SECTION 14. SECTION 20A-9-101 IS AMENDED TO READ:  
20A-9-101. Definitions.

(12) "Registered political party" means the same as that term is defined in Section 20A-8-101. (12) "Qualified political party" means a registered political party that:

- (a) permits a delegate for the registered political party to vote on a candidate nomination in the registered political party's convention remotely; or
- (b) provides a procedure for designating an alternate delegate if a delegate is not present at the registered political party's convention;
- (c) does not hold the registered political party's convention before the fourth Saturday in March of an even numbered year;
- (d) permits a member of the registered political party to seek the registered political party's nomination for any elective office by the member choosing to seek the nomination by either or both of the following methods:
  - (i) seeking the nomination through the registered political party's convention process, in accordance with the provisions of Section 20A-9-407; or
  - (ii) seeking the nomination by collecting signatures, in accordance with the provisions of Section 20A-9-408; and
- (e) if the registered political party is a continuing political party, no later than 5 p.m. on September 30 of an odd numbered year, certifies to the lieutenant governor that, for the election in the following year, the registered political party intends to nominate the registered political party's candidates in accordance with the provisions of Section 20A-9-406; or
- (f) if the registered political party is not a continuing political party, certifies at the time that the registered political party files the petition described in Section 20A-8-403 that, for the next election, the registered political party intends to nominate the registered political party's candidates in accordance with the provisions of Section 20A-9-406.]

SECTION 15. SECTION 20A-9-202 IS AMENDED TO READ:

20A-9-202. Declarations of candidacy for regular general elections.

(1)(a) Each person seeking to become a candidate for an elective office that is to be filled at the next regular general election shall:

- (i) file a declaration of candidacy in person with the filing officer on or after January 1 of the regular general election year, [and, if applicable,] or before the candidate circulates nomination petitions under Section 20A-9-405; and
- (ii) pay the filing fee.

(b) Each county clerk who receives a declaration of candidacy from a candidate for multicounty office shall transmit the filing fee and a copy of the candidate's declaration of candidacy to the lieutenant governor within one working day after it is filed.

(c) Each day during the filing period, each county clerk shall notify the lieutenant governor electronically or by telephone of candidates who have filed in their office.

(d) Each person seeking the office of lieutenant governor, the office of district attorney, or the office of president or vice president of the United States shall comply with the specific declaration of candidacy requirements established by this section.

(2)(a) Each person intending to become a candidate for the office of district attorney within a multicounty prosecution district that is to be filled at the next regular general election shall:

- (i) file a declaration of candidacy with the clerk designated in the interlocal agreement creating the prosecution district on or after January 1 of the regular general election year, and before the candidate circulates nomination petitions under Section 20A-9-405; and
- (ii) pay the filing fee.

(b) The designated clerk shall provide to the county clerk of each county in the prosecution district a certified copy of each declaration of candidacy filed for the office of district attorney.

(3)(a) [On or before 5 p.m. on the first Monday after the third Saturday in April] At least five days prior to the date specified in Subsection 20A-9-403(d)(ii), each lieutenant governor candidate shall:

- (i) file a declaration of candidacy with the lieutenant governor;
- (ii) pay the filing fee; and
- (iii) submit a letter from a candidate for governor who has [received certification] qualified or attempted to qualify for the primary-election ballot under Section 20A-9-403 that names the lieutenant governor candidate as a joint-ticket running mate.

(b) Any candidate for lieutenant governor who fails to timely file is disqualified. If a lieutenant governor is disqualified, another candidate shall file to replace the disqualified candidate.

SECTION 1. SECTION 20A-1-102 IS AMENDED TO READ:  
20A-1-102. Definitions.

(24) "Election" means a regular general election, a municipal general election, a statewide special election, a local special election, a regular primary election, a runoff election, a municipal primary election, and a local district election.

(80) "Ticket" means a list of:  
(a) registered political parties that have chosen to nominate all candidates for elective office through direct primary election pursuant to Section 20A-9-403;(b) candidates for an office; or  
(c) ballot propositions.

SECTION 2. SECTION 20A-1-103 IS AMENDED TO READ:  
20A-1-103. Severability clause.

If any provision of the Direct Primary Election Initiative of 2018 [Laws of Utah 2014, Chapter 17], or the application of any provision of that Initiative [Laws of Utah 2014, Chapter 17], to any person or circumstance is held invalid by a final decision of a court of competent jurisdiction, the remainder of that Initiative [Laws of Utah 2014, Chapter 17] shall be given effect without the invalid provision or application. The provisions of the Direct Primary Election Initiative of 2018 [Laws of Utah 2014, Chapter 17] are severable.

SECTION 3. SECTION 20A-1-104 IS ENACTED TO READ:

20A-1-104. Repeal of certain provisions.

All acts and parts of acts related to the nomination or election of candidates for elective office that were enacted between November 1, 2017 and the enactment of this Section are hereby repealed, to the extent they conflict with the text or purpose of the Direct Primary Election Initiative of 2018. This Section is intended solely to prevent the Legislature's potential interference in the initiative process and to preserve the ability of the People of the State of Utah to express their will as to the nomination and election of candidates for elective office through the Direct Primary Election Initiative of 2018. This Section shall not be construed to alter the power given to the Legislature under Section 20A-7.

SECTION 4. SECTION 20A-1-201.5 IS AMENDED TO READ:  
20A-1-201.5. Primary election dates.


(1) A regular primary election shall be held throughout the state on the first [fourth] Tuesday of June of each even numbered year as provided in Section 20A-9-403[; 20A-9-407, or 20A-9-408, as applicable] to nominate persons for:  
(a) national, state, school board, and county offices; and  
(b) offices for a metro township, city, or town incorporated under Section 10-2a-404.

SECTION 5. SECTION 20A-3-308 IS AMENDED TO READ:  
20A-3-308. Absentee ballots in the custody of poll workers—Disposition—Notice.

(5)(a) If the election officer rejects an individual's absentee ballot because the election officer determines that the signature on the ballot does not match the individual's signature that is maintained on file, the election officer shall contact the individual in accordance with Subsection (7) by mail, email, text message, or phone, and inform the individual:  
(i) that the individual's signature is in question;  
(ii) how the individual may resolve the issue;  
(iii) that, in order for the ballot to be counted, the individual is required to deliver to the election officer a correctly completed affidavit, provided by the county clerk, that meets the requirements described in Subsection (5)(b).  
(b) An affidavit described in Subsection (5)(a)(iii) shall include:  
(i) an attestation that the individual voted the absentee ballot;  
(ii) a space for the individual to enter the individual's name, date of birth, and driver license number or the last four digits of the individual's social security number;  
(iii) a space for the individual to sign the affidavit; and  
(iv) a statement that, by signing the affidavit, the individual authorizes the lieutenant governor's and county clerk's use of the individual's signature on the affidavit for voter identification purposes.  
(c) In order for an individual described in Subsection (5)(a) to have the individual's ballot counted, the individual shall deliver the affidavit described in Subsection (5)(b) to the election officer no later than the end of the business day before the election canvass.  
(d) An election officer who receives a signed affidavit under Subsection (5)(c) shall immediately:  
(i) scan the signature on the affidavit electronically and keep the signature on file in the statewide voter registration database developed under Section 20A-2-109; and  
(ii) if the canvass has not concluded, count the individual's ballot.  
(6) An election officer who rejects an individual's absentee ballot for any reason, other than the reason described in Subsection (5)(a), shall notify the individual of the rejection in accordance with Subsection (7) by mail, email, text message, or phone and specify the reason for the rejection.  
(7) An election officer who is required to give notice under Subsection (5) or (6) shall give the notice no later than:  
(a) if the election officer rejects the absentee ballot before election day:  
(i) one business day after the day on which the election officer rejects the absentee ballot, if the election officer gives the notice by email or text message; or  
(ii) two business days after the day on which the election officer rejects the absentee ballot, if the election officer gives the notice by postal mail or phone;  
(b) [seven days after election] the day prior to the canvass, if the election officer rejects the absentee ballot on election day; or  
(c) seven days after the canvass if the election officer rejects the absentee ballot after election day and before the end of the canvass.

SECTION 6. SECTION 20A-4-301 IS AMENDED TO READ:  
20A-4-301: Board of canvassers.

(1)(a) Each county legislative body is the board of county canvassers for:  
(i) the county; and  
(ii) each local district whose election is conducted by the county if:  
(A) the election relates to the creation of the local district;

Talking with Brian McKenzie the intention is to make sure counties can still mail out ballots up to seven days before, but I am concerned that the law would allow a county or city to wait until seven days

3. Oregon requires a minimum of two drop boxes per county. This might not make sense for small counties. Too much of a burden? Some possible ways to tier this requirement:

- a. Two minimum for counties of class 1-4. One minimum for class 5-6.
- b. Some kind of ratio between population and square mileage of the county.
- c. A minimum distance between at least two boxes (for geographically large counties).
- d. A box required for each city whose citizens comprise more than X% of the county's total population.

**What thoughts/recommendations do you have on this idea?** Probably a simple solution would be easiest to implement and manage as the population grows.

Hi everyone,

I need your advice to figure out how to deal with our plain language bill.

**Background:** The Gov Ops committee approved this as a committee bill in Interim. For various reasons (most of which were my fault), the language of the bill actually makes the ballots and inserts longer. In short - most of the bill needs to be dropped or rewritten for it to accomplish what we want it to accomplish. Originally, I had planned to scrap the entire bill, except for the last page that consolidates judge retention questions, and even that page looks may get some pushback from the state courts.

Under normal circumstances, I'd recommend we scrap the entire bill and regroup for next year, but I was contacted over the weekend by Rep. Steve Christiansen of West Jordan (replaced Ken Ivory). We met tonight and he wants to make the initiatives/referenda more readable for the voters. His intent language is in the email chain below, but in short, his intent would make the ballots much longer than they are now. We agreed that it's in everyone's best interest for us to try to come up with language that satisfies everyone, if at all possible.

So what do we do now? Here are some options:

1. scrap our committee bill until next year and fight his bill.
2. try to incorporate his intent into our committee bill in a manner that works for us and him.
3. Try to fix our committee bill and work with him separately on his bill.
4. Tweak our committee bill to focus solely on judge retention.
5. Other ideas - I'm sure there are plenty of options

Other thoughts:

- I don't see a feasible way that we can accomplish both his and our goals. He wants the additional language right on the ballot, not in an insert. He did agree that perhaps

affiliation just for the primary to have a voice in the heavily Republican state for the many races here that are essentially decided in the GOP primary. Democratic leader Kem Gardner also wrote a Tribune op-ed urging the same saying the real Utah governor's race is in June not November, given that a Democrat hasn't been elected to the office in 40 years.

So, people who re-registered since May 15 initially received a ballot for their former party; they were unaffiliated, they may have received a ballot for nonpartisan primaries for local school boards.

"Most Democrats who re-affiliated understand that they received a Democratic ballot" and another may come because of the timing, Swensen said. "But many former unaffiliated voters that receive a nonpartisan school board ballot are like, 'Oh, I registered with the Republican Party, but I only got a ballot with the school board.'"

Swensen said all counties have the same practice to automatically void the earlier ballot for such people, "so it won't count if they send it in." And clerks send out a new one.

She said people have a deadline of June 19 to register or switch party affiliation and still receive a new by-mail ballot. Unaffiliated voters (but not Democrats) may also register as Republican at in-person election day voting centers or at early voting sites.

If you recently switched from Unaffiliated to Republican, you may have been sent a nonpartisan ballot. **If you happened to have already completed and sent in the nonpartisan ballot before receiving your Republican ballot, do not worry. You still have the option to complete and send in your Republican ballot as soon as it arrives in your mailbox.** Your county clerk will then ensure that the nonpartisan ballot you may have sent in will not count. Instead, they will count your Republican ballot.

The same process applies to Democrats who may have switched to Republican. If you happen to have already completed and sent in your Democratic ballot, you can still send in your Republican ballot once it arrives in your mailbox. Your county clerk will not count your Democratic ballot, and will instead count your Republican ballot.
