If you are one of the thousands of Utah voters who have recently switched party registration from unaffiliated or Democrat to Republican and received a by-mail ballot this week that contained no Republican races, no need to worry, election officials say.

It's just a timing issue.

Ballots were mailed by the June 9 deadline, and reflect registration status when mailings were prepared. But people who recently switched party registration to Republican, will indeed get the GOP ballots they want and the initial ballots without Republican races have been automatically voided.

"We've had lots of phone calls and emails because you know that this happens every primary. It happened in the presidential primary" in March, said Salt Lake County Clerk Sherrie Swensen. She's also sent emails to people who recently switched party status to explain the situation.

She explains that to have ballots mailed by the legal June 9 deadline, she had to send vendors lists of how people were registered as of May 15 — as did most other counties.

"But there have been a lot of changes since then," she notes.

Good morning,

I don't believe this happens in Utah, but a legislator reached out to me with concerns so I told him I would double-check. We want to do whatever we can to give people confidence in voting by mail.

There is a video circulating on social media that shows by mail ballot envelopes and included in the barcode number is an R or a D. The video claims this shows a voter's party affiliation and a malicious actor could identify R or D ballots and

(unlikely). Just wanted you to be aware of the outcome of our conversation. By the end of the week you'll have direction from us as to how to proceed.

Marc, as we discussed by phone, the following are the drafting instructions I've provided for my proposed bill:

For ballot initiatives/referenda/constitutional amendments: Require on the ballot 2-3 explanatory bullet points for and 2-3 against for all initiatives/referenda/constitutional amendments to improve transparency and to help voters understand the implications of voting for or against the proposed initiative. Also, establish an independent commission that will study each proposed ballot initiative that has received adequate, qualified signatures and issue a statement that will be included on the ballot briefly stating whether the ballot, as written, can be implemented or if it will require legislative involvement if passed.

2. try to incorporate his intent into our committee bill in a manner that works for us and him.
3. Try to fix our committee bill and work with him separately on his bill.
4. Tweak our committee bill to focus solely on judge retention.
5. Other ideas - I'm sure there are plenty of options

Other thoughts:

- I don't see a feasible way that we can accomplish both his and our goals. He wants the additional language right on the ballot, not in an insert. He did agree that perhaps shortening the original ballot language to a very short ballot title, then adding the argument bullet points for/against might be possible, but even that is quite long.
- He said that he'll run his own bill if we can't figure out a way to get this in our bill. Not threatening, but this is his top priority bill.
- He thinks the additional cost and potential voter confusion of a 2-card ballot is worth it if it means the voters better understand these difficult-to-understand initiatives and referenda.
- The independent commission opinion on whether a certain initiative could be implemented or not might resonate with the legislature after medical cannabis and medicaid expansion had to be changed, and the legislature got heat for doing what needed to be done.
- He's brand new. How much influence can he have on the process and what's the chance of his success in this?
- I don't want to fight against him. Would prefer to have a good relationship, and it would look bad to the committee if we say we want plain language and then fight a plain language bill.
- I'm not sure I have the bandwidth to rewrite our committee bill between now and the start of the session. Not sure any of you have bandwidth either, with that little March 3 election coming up.
- How bad would it look to scrap or dramatically alter our bill, after it was made a committee bill?

I'm unsure how best to proceed and could use your ideas. I got Steve to agree to wait until Friday for a response and direction.




What Bill Does
Clarifies what a campaign expenditure is; modifies financial reporting deadlines; modifies certain penalties for person who violates campaign & political advertisement provisions
Allow 16-17 year olds to vote in local school board races.
Requires 1st & 2nd class counties to establish an inventory to classify competitive activities; and before authorizing specified competitive activities, to conduct a market impact study and hold a public hearing. For 1st-4th class, for recreation (golf course, rec center, etc.) need to do feasibility study.
provides the circumstances under which a county auditor may conduct a tax sale of real property electronically; updates the location information for the tax sale in the notice requirement
Relates to cure letters, voter notification, and signature comparison
Raises exemption amount on personal property from \$15K to \$25K. Sub would exclude accounts under \$25K. Full tax if >\$25K. Would prevent this from being revisited each year.
Circuit Breaker changes. Links statutory income requirements to CPI.
After 2024, requires counties to defer property taxes for all property owners age 70 and over whose homes are worth \$500K or less. Income test for circuit breaker set to 2.5X, rather than 1.5X. Sets interest rate to 3-3.5%. Can defer if resided in house > 15 years.
Allows an RDA/CRA agency to levy a property tax on property, prohibits RDA/CRA from extending the scope of certain project area plans/budgets; allows the agency to use property tax revenue for agency-wide project development; requires the agency to adopt an implementation plan to guide agency-wide project development;
Prohibits collecting the uniform fee more than once per year on leased vehicle purchase by leasee
Requires more detailed expenditure reporting for state candidates.
County Animal Control Amendments for 2nd-5th class counties.
Eliminates newspaper publication requirements for several types of notices, including several election notices.
