I appreciate your time."

- Protection of voter information has been a long standing issue and concern. The public is opposes the open sharing of their data to anyone who wants it. Currently there are little to no restrictions on what can be done with the data regardless of the intended use.
- The purpose of gathering voter information is to facilitate the election process in the State of Utah, but others have used it as an easily accessible Data "Treasure Trove" and used it for their own interests.
- For over a decade County Clerks have lobbied the legislature to improve protections for voter information we believe the legislature accomplished that by allowing individuals to make the decision to privatize there information.
- SB83 removes the ability for a citizen to choose to have their information protected (without cause). It still allows the majority of voter information to be made available to the public.

"Ballots are ordered by sending an extract or list to the printer. Ballots are ordered only for active registered voters, and each ballot is assigned a unique ballot ID number correlated to a voter in the database. That ID number is printed on the return envelope. When a ballot is returned by the voter, the ID number on the envelope is scanned and the voter is immediately given credit in the database for having returned their ballot. If a voter doesn't receive their ballot or ruins their ballot and requests a new one, the ballot that was originally ordered for that voter is spoiled in the database. A new ballot is ordered for the voter with a different ballot ID number."

SB114 – Election Law Amendments

As County Clerks have the statutory duty to serve as the election officers for each county and as the election administrator for all federal state and county elections we have reviewed the proposals made in SB114 and provide this information for consideration.

From the County's point of view there are two primary concerns with this proposed bill

1. An administratively impossible timeline for election officials to meet.

The primary election will be held on June 26, 2018, a county would complete the canvass of the primary election on July 11, 2018 and the state would complete their canvass on July 13, 2018. Ballots for a by mail runoff election will need to enter the mail system on July 24, 2018 (three weeks prior to the runoff). Under the current proposal it would provide seven (7) business days from the date of the state canvass to the date that ballots will need to be mailed to the voters.

Seven business days is not sufficient time to plan and prepare for an election. Included is a list of the minimum tasks that must be completed with their associated timeline in order to appropriately prepare for a runoff election.

Proposed Solution- Move the primary election day to the first week in June.

As currently provided for in state statute we average a 60 day preparation widow for each election. As clerks we have reviewed our procedures, associated tasks, and statutory requirements that need to be accomplished, and believe that these could be accomplished within the 53 days provided by moving the primary to the first week in June. This is the absolute minimum time we need to provide the citizens with a secure, efficient, and accurate election.

2. Lack of clarity on the financial support provided by the state for the cost of a runoff election.

Current estimate on a statewide runoff type of an election is \$2.9 million. The current draft says "within funds appropriated by the Legislature for this purpose, the lieutenant governor shall reimburse each county for the expense, as determined by the lieutenant governor, of conducting a runoff election under this section" Yet this bill does not appropriate any monies for this purpose, nor does it provide a guarantee that the amount determined by the lieutenant governor will cover the full cost incurred by a county.

Proposed Solution- Provide a method that requires the legislature to appropriate adequate funds for this purpose and a specified process that will provide a full reimbursement of county expenses for each runoff election.

"But there have been a lot of changes since then," she notes.

For example, former Democratic state senator Jim Dabakis urged Democrats to switch affiliation just for the primary to have a voice in the heavily Republican state for the many races here that are essentially decided in the GOP primary. Democratic leader Kem Gardner also wrote a Tribune op-ed urging the same saying the real Utah governor's race is in June, not November, given that a Democrat hasn't been elected to the office in 40 years.

So, people who re-registered since May 15 initially received a ballot for their former party. If they were unaffiliated, they may have received a ballot for nonpartisan primaries for local school boards.

"Most Democrats who re-affiliated understand that they received a Democratic ballot" and another may come because of the timing, Swensen said. "But many former unaffiliated voters that receive a nonpartisan school board ballot are like, 'Oh, I registered with the Republican Party, but I only got a ballot with the school board.'"

Swensen said all counties have the same practice to automatically void the earlier ballot sent to such people, "so it won't count if they send it in." And clerks send out a new one.

She said people have a deadline of June 19 to register or switch party affiliation and still receive a new by-mail ballot. Unaffiliated voters (but not Democrats) may also register as Republican at in-person election day voting centers or at early voting sites.



If you recently switched from Unaffiliated to Republican, you may have been sent a nonpartisan ballot. **If you happened to have already completed and sent in the nonpartisan ballot before receiving your Republican ballot, do not worry. You still have the option to complete and send in your Republican ballot as soon as it arrives in your mailbox.** Your county clerk will then ensure that the nonpartisan ballot you may have sent in will not count. Instead, they will count your Republican ballot.

The same process applies to Democrats who may have switched to Republican. If you happen to have already completed and sent in your Democratic ballot, you can still send in your Republican ballot once it arrives in your mailbox. Your county clerk will not count your Democratic ballot, and will instead count your Republican ballot.

If you happened to have already completed and sent in the nonpartisan ballot before receiving your Republican ballot, do not worry. You still have the option to complete and send in your Republican ballot as soon as it arrives in your mailbox. Your county clerk will then ensure that the nonpartisan ballot you may have sent in will not count. Instead, they will count your Republican ballot.

That certainly is true IF the voter spoils the ballot before we scan the envelope, but this ad doesn't say that. I think it may lead voters to think that they could cancel it any time, and we would spoil the ballot.

Anyway, just thought I'd share.

Counties that use the absentee ID can pull spoiled ballots out and then count the active ballot that comes in. Some counties use the voter ID, and they count the first ballot that comes in.

Brian and Sherrie make excellent points about the Affiliation deadline and the extracts. 11 days versus 30 days makes little difference because some counties send their extract as early as 50-55 days before an election. We've been dealing with this for years. We usually have to send our extracts between 35-45 days before because of the national volume and the fact that we truck them to Salt Lake. To capture all affiliation changes it would have to be 60 days and would disenfranchise thousands of voters. That would however make some campaigns very happy.

I don't have time to research all of the areas, but here are a couple of sections of code. I bolded the important parts.

20A-4-106. Manual ballots -- Sealing.

(1) **After the official canvas of an election, the election officer shall store all election returns in containers that identify the containers' contents.**

(2) **After the ballots are stored under Subsection (1), the ballots may not be examined by anyone, except when examined during a recount conducted under the authority of Section 20A-4-401 or Title 20A, Chapter 4, Part 6, Municipal Alternate Voting Methods Pilot Project.**

20A-4-202. Election officers -- Disposition of ballots -- Release of number of provisional ballots cast.

(1) Upon receipt of the election returns from the poll workers, the election officer shall:

- (a) ensure that the poll workers have provided all of the ballots and election returns;
- (b) inspect the ballots and election returns to ensure that they are sealed;
- (c) for manual ballots, deposit and lock the ballots and election returns in a safe and secure place;
- (d) for mechanical ballots:
 - (i) count the ballots; and
 - (ii) deposit and lock the ballots and election returns in a safe and secure place; and
- (e) for bond elections, provide a copy of the election results to the board of canvassers of the local political subdivision that called the bond election.

(2) Each election officer shall:

- (a) before 5 p.m. on the day after the date of the election, determine the number of provisional ballots cast within the election officer's jurisdiction and make that number available to the public;
- (b) **preserve ballots for 22 months after the election or until the time has expired during which the ballots could be used in an election contest;**
- (c) **preserve all other official election returns for at least 22 months after an election; and**
- (d) **after that time, destroy them without opening or examining them.**

(3)

- (a) The election officer shall package and retain all tabulating cards and other materials used in the programming of the automatic tabulating equipment.
- (b) The election officer:
 - (i) may access these tabulating cards and other materials;
 - (ii) may make copies of these materials and make changes to the copies;
 - (iii) may not alter or make changes to the materials themselves; and
 - (iv) within 22 months after the election in which they were used, may dispose of those materials or retain them.

(4)

- (a) If an election contest is begun within 12 months, the election officer shall:
 - (i) keep the ballots and election returns unopened and unaltered until the contest is complete; or
 - (ii) surrender the ballots and election returns to the custody of the court having jurisdiction of the contest when ordered or subpoenaed to do so by that court.
- (b) When all election contests arising from an election are complete, the election officer shall either:
 - (i) retain the ballots and election returns until the time for preserving them under this section has run; or

specifically, the date that the absentee ballot was mailed to the voter, and the date that the voted absentee ballot was received by the election officer.
