DIRECT PRIMARY ELECTION ACT

- The Governor's Office of Management and Budget estimates the law proposed by this initiative would result in a total fiscal expense of up to \$3.35 million every two years, including costs for runoff elections (up to \$2.9 million), additional primary elections (up to \$400,000), and signature verification and miscellaneous costs (approximately \$50,000). Candidate and voter behavior may change these estimates. In addition, the cost of posting information regarding the proposed initiative in Utah's statewide newspapers and for printing the additional pages in the voter information pamphlet is estimated at \$30,000 in one-time funds.
- **WARNING:** It is a class A misdemeanor for an individual to sign an initiative petition with a name other than the individual's own name, or to knowingly sign the individual's name more than once for the same measure, or to sign an initiative petition when the individual knows that the individual is not a registered voter and knows that the individual does not intend to become registered to vote before the certification of the petition names by the county clerk.
- Birth date or age information is not required, but it may be used to verify your identity with voter registration records. If you choose not to provide it, your signature may not be verified as a valid signature if you change your address before petition signatures are verified or if the information you provide does not match your voter registration records.

We'd like to discuss these two issues (funding is most crucial) with a smaller group before opening it up to the full Legislative group.



In accordance with [Utah Code 20A-9-202\(5\)](#), the Office of the Lieutenant Governor is filing a written objection to the declaration of candidacy of Cindie Quintana due to the following reason:

- Candidates must submit a conflict of interest disclosure electronically as required by [Utah Code 20A-11-1603](#) and [20A-9-202\(3\)\(e\)](#).
- Cindie did not submit a conflict of interest disclosure electronically.
- Cindie requested access to the [disclosures.utah.gov](#) website at 3:35 pm on March 19, 2020, and our office approved her access at 3:36 pm on the same day, thus allowing Cindie to submit the conflict of interest disclosure. Attached is the confirmation email that was sent to cindiequintana@gmail.com at 3:36 pm.

The objection process requires your office to notify the candidate immediately and decide this objection within 48 hours. If you sustain the objection, Cindie may cure the issue by submitting a conflict of interest disclosure before 5:00 pm within three days after the day on which the objection is sustained. Refer to [Utah Code 20A-9-202\(5\)](#).

Good evening,

Please read the attached executive order from Governor Herbert. Due to the potential for candidates to be quarantined during the declaration of candidacy period, the Governor has suspended the requirement that candidates must file in person during the declaration of candidacy period. Any candidate can use the remote filing provisions under Utah Code § 20A-9-202(1)(c), even if the candidate is not out of town.

Q - Does this mean that candidates have to file remotely?

A - No. Candidates can still file in person.

Q - How does remote filing work?

A - See 20A-9-202(1)(c). Basically the candidate sends an agent with their paperwork, and the filing officer communicates with the candidates via some type of video communication. The agent cannot sign the declaration paperwork on the candidate's behalf.

Dear Standards Board Members:

On behalf of the newly designated Standards Board Designated Federal Official, Donald Palmer, I am forwarding to you, the eight candidates who have been nominated to fill the eight vacancies on the Executive Board Committee.

There are three 1- term positions (2 year duration), three 2-term positions (4 year duration) and two positions to complete the remainder of two 3-term positions (6 year duration). The two individuals elected to complete these two 3-term positions will serve the remaining 2 years of the 6-year duration, which expires in April 2021.

HAVA requires that the nine-member (9) Executive Board be comprised of:

- ~ not more than five (5) State election officials
- ~ not more than five (5) local election officials
- ~ not more than five (5) of the same political party

Because there are not more than five (5) members of the same political party on the current Executive Board, the new members may be of either party or unaffiliated. The election will be conducted using plurality voting. The Standards Board Bylaws do not allow for proxy voting for Executive Board members. Therefore, all members who intend to cast a vote for Executive Board members must be present at this meeting.

We are attaching three documents to this letter to assist in the nomination process: (1) a copy of HAVA section 213(c), which governs the selection of the Executive Board; (2) a copy of the Bylaws, and (3) the candidate nominations. Voting will be held on the first day of the meeting, with election results to be announced by the end of the day.

As we get closer to the meeting date, we will forward the minutes of the 2018 meeting and other pertinent information for your use.

Dear Standards Board Member:

The Standards Board will be meeting during the week of April 8th thru April 12, 2019 to fulfill its Help America Vote Act obligations. The Election Assistance Commission (EAC) is working on arrangements for the meeting and will be sending you more detailed information in the coming months.

The purpose of this letter is to explain the Standards Board Executive Board positions and to seek nominations for the vacancies. At this meeting, it is necessary for the Standards Board members to elect executive board members to three 2-year terms that will expire on April 28, 2021 and three 4-year terms that will expire on April 28, 2023. Members will also elect one member to serve the remainder of one 6-year term that expires on April 28, 2021.

The three 2-year terms are currently held by designated local election officials Greg Riddlemoser from Stafford County Virginia, Reynaldo Valenzuela from Maricopa County, Arizona, and Genevieve Whitaker from the U.S. Virgin Islands, who stepped down in 2018. The three 4-year terms are currently held by designated state election officials Brad King from Indiana, Gary Poser from Minnesota, who is retiring this month, and Edgardo Cortes from Virginia, who stepped down in 2018. The one 6-year term was held by designated local election official Jerry Schwarting from South Dakota, who retired in December 2017. The person elected to this term will serve the remaining 2 years of the 6-year term, which expires in April 2021.

HAVA requires that the nine-member (9) Executive Board be comprised of:

- ~ not more than five (5) State election officials
- ~ not more than five (5) local election officials
- ~ not more than five (5) of the same political party

The Standards Board may elect up to three (3) State and four (4) local officials, or two (2) State and five (5) local officials, and because there are not more than five (5) members of the same political party on the current Executive Board, the new members may be of either party or unaffiliated. The election will be conducted using plurality voting. The positions will be filled based on the greatest number of votes received. If three State officials are elected, the remaining positions will be filled by local officials. The Standards Board Bylaws do not allow for proxy voting for Executive Board members.

SEC. 213. MEMBERSHIP OF STANDARDS BOARD.

(a) COMPOSITION.—

(1) IN GENERAL.—Subject to certification by the chair of the Federal Election Commission under subsection (b), the Standards Board shall be composed of 110 members as follows:

(A) Fifty-five shall be State election officials selected by the chief State election official of each State.

(B) Fifty-five shall be local election officials selected in accordance with paragraph (2).

(2) LIST OF LOCAL ELECTION OFFICIALS.—Each State's local election officials, including the local election officials of Puerto Rico and the United States Virgin Islands, shall select (under a process supervised by the chief election official of the State) a representative local election official from the State for purposes of paragraph (1)(B). In the case of the District of Columbia, Guam, and American Samoa, the chief election official shall establish a procedure for selecting an individual to serve as a local election official for purposes of such paragraph, except that under such a procedure the individual selected may not be a member of the same political party as the chief election official.

(3) REQUIRING MIX OF POLITICAL PARTIES REPRESENTED. — The two members of the Standards Board who represent the same State may not be members of the same political party.

(b) PROCEDURES FOR NOTICE AND CERTIFICATION OF APPOINTMENT.—

(1) NOTICE TO CHAIR OF FEDERAL ELECTION COMMISSION.— Not later than 90 days after the date of the enactment of this Act, the chief State election official of the State shall transmit a notice to the chair of the Federal Election Commission containing—

(A) the name of the State election official who agrees to serve on the Standards Board under this title; and

(B) the name of the representative local election official from the State selected under subsection (a)(2) who agrees to serve on the Standards Board under this title.

(2) CERTIFICATION.—Upon receiving a notice from a State under paragraph (1), the chair of the Federal Election Commission shall publish a certification that the selected State election official and the representative local election official are appointed as members of the Standards Board under this title.

(3) EFFECT OF FAILURE TO PROVIDE NOTICE.—If a State does not transmit a notice to the chair of the Federal Election Commission under paragraph (1) within the deadline described in such paragraph, no representative from the State may participate in the selection of the initial Executive Board under subsection (c).

(4) ROLE OF COMMISSION.—Upon the appointment of the members of the Election Assistance Commission, the Election Assistance Commission shall carry out the duties of the Federal Election Commission under this subsection.
