Domestic Violence

WHAT IS DOMESTIC VIOLENCE?

Domestic violence is the willful intimidation, physical assault, battery, sexual assault, and/or other abusive behavior as part of a systematic pattern of power and control perpetrated by one intimate partner against another. It includes physical violence, sexual violence, threats, and emotional/psychological abuse. The frequency and severity of domestic violence varies dramatically.

DID YOU KNOW?

- In the United States, an average of 20 people experience intimate partner physical violence every minute. This equates to more than 10 million abuse victims annually.¹
- 1 in 4 women and 1 in 9 men experience severe intimate partner physical violence, intimate partner contact sexual violence, and/or intimate partner stalking with impacts such as injury, fearfulness, post-traumatic stress disorder, use of victim services, contraction of sexually transmitted diseases, etc.² This is commonly considered "domestic violence".
 - 1 in 3 women and 1 in 4 men have experienced some form of physical violence by an intimate partner. This includes a range of behaviors and in some cases might not be considered "domestic violence".³
 - 1 in 7 women and 1 in 25 men have been injured by an intimate partner.⁴
 - 1 in 10 women have been raped by an intimate partner. Data is unavailable on male victims.⁵
 - 1 in 7 women and 1 in 18 men have been stalked. Stalking causes the target to fear she/he/they or someone close to her/him/them will be harmed or killed.⁶
- On a typical day, domestic violence hotlines nationwide receive over 20,000 calls.⁷
- An abuser's access to a firearm increases the risk of intimate partner femicide by 400%.⁸
- Intimate partner violence accounts for 15% of all violent crime.⁹
- Intimate partner violence is most common against women between the ages of 18-24.¹⁰
- 19% of intimate partner violence involves a weapon.¹¹

WHY IT MATTERS

Domestic violence is prevalent in every community, and affects all people regardless of age, socio-economic status, sexual orientation, gender, race, religion, or nationality. Physical violence is often accompanied by emotionally abusive and controlling behavior as part of a much larger, systematic pattern of dominance and control. Domestic violence can result in physical injury, psychological trauma, and even death. The devastating consequences of domestic violence can cross generations and last a lifetime.

SEXUAL ASSAULT

- 1 in 5 women and 1 in 59 men in the United States is raped during his/her lifetime.¹²
- 9.4% of women in the United States experience intimate partner sexual assault in their lifetimes.¹³

STALKING

- 19.3 million women and 5.1 million men in the United States have been stalked.¹⁴
- 66.2% of female stalking victims reported stalking by a current or former intimate partner.¹⁵

Access To and Use Of Voter Registration Lists

Overview



This page provides 50-state information on access to voter lists. States have varied requirements on who is eligible to request a list of voters, what information the list contains, what information is kept confidential, and how information contained in voter lists may be used. Many states also have specific programs to keep all voter information confidential for certain classes of voters.

The availability of voter lists for campaign purposes is longstanding; candidates benefit from knowing who their party's voters are. Statutes govern the details. Legislators who are interested in expanding or restricting access to voter information may want to consider the following questions:

- Who should have the access? Only political parties and candidates, the general public, academics, others?
- What information will not be provided when voter lists are distributed? Date of birth, driver's license numbers, other identifying information?
- What provisions are made to protect information for people who require address confidentiality, such as victims of domestic violence, sexual assault or stalking? (Learn more about Address Confidentiality Programs here).
- Should law enforcement agents or judges be provided with similar confidentiality?
- Is information about pre-registrants, or those under the age of 18 who are pre-registered to vote and are thus minors, be confidential?
- What process for requesting and receiving voter lists is appropriate? Some states provide a portal for access, others may run a custom extract of voter registration data depending on the information requested.
- Are there restrictions on the uses of the lists, such as that they cannot be used for commercial gain?
- Is there a mechanism for enforcing that policies are followed?
- What is an appropriate fee for voter lists? See the United States Election Project for more information.

In looking over the points brought up by Representative Christiansen, I don't believe this is in line with the original intent of the bill. As I understand it our goal is to only place the absolute necessary information on the ballot and then refer the voter to the insert or other resources for more comprehensive information.

I agree with the concept of providing simple, and easy to understand information to the voter, and I agree with providing that information with the ballot; however, I don't see the need of placing the information directly on the ballot. At the end of the day, all I need returned to my office are the voter's choices, I don't need all of the descriptive information that helps to inform the voter of the issues.

As it relates to the bill itself, can you share what changes you are aware of that need to be made from our end? As a committee bill, I believe the less we can modify the better.

I would propose dropping the judicial portion out of the bill. I don't see it as a major help as the multiple judges are on our municipal ballots anyway. This is a concern for the judicial and not a help for us.

Hi everyone,

I need your advice to figure out how to deal with our plain language bill.

Background: The Gov Ops committee approved this as a committee bill in Interim. For various reasons (most of which were my fault), the language of the bill actually makes the ballots and inserts longer. In short - most of the bill needs to be dropped or rewritten for it to accomplish what we want it to accomplish. Originally, I had planned to scrap the entire bill, except for the last page that consolidates judge retention questions, and even that page looks may get some pushback from the state courts.

Under normal circumstances, I'd recommend we scrap the entire bill and regroup for next year, but I was contacted over the weekend by Rep. Steve Chritiansen of West Jordan (replaced Ken Ivory). We met tonight and he wants to make the initiatives/referenda more readable for the voters. His intent language is in the email chain below, but in short, his intent would make the ballots much longer than they are now. We

Consistency is what we have asked for as election administrators. We should hold to that. If the Legislature, Governor and Lieutenant Governor are committed to full implementation of RCV for all elected offices in the State, then the Clerks must be fully committed. This wasn't just a strategy to avoid RCV, it was a commitment. The Clerks have always been committed to administering fair, transparent, and accessible elections. Under RCV, full implementation gives us the best opportunity to do that. Naturally, we remain consistent in our belief that RCV is an extremely bad idea with significant administrative challenges and the potential for increased voter confusion. If RCV is to be forced upon the State, full implementation is the way to go for everyone's sake.

Good ideas grow organically, just like vote by mail did from 2012 to 2020. VBM never required legislative mandates in order for it to take root in the State. Interesting, that after a "successful" pilot, the only way RCV moves forward is through legislative mandates. Perhaps this is the best indication of how good of an idea RCV is.

I attended the Committee meeting on Friday and had the chance to speak with the brains of the bill (Prof. Robin Fretwell Wilson) after the meeting. Ricky has done a great job of summarizing what took place. I would like to emphasize a few additional items that I believe are important:

1. The County Clerk choosing not to perform marriages for anyone is not considered a solution on this issue.
2. It is important that the "designee" of the Clerk not be required to be an employee of the County. They can be, but they don't have to be. This is important because towards the end of the hearing, it seemed the discussion shifted toward the designee having to be an employee. I have no interest in setting down with my staff to find out who has deeply held religious views one way or the other on this issue. I would rather pull from a pool in the community that are willing to make themselves "reasonably available" to perform marriages.
3. There should be a distinction that the designee is not deputized.

Mrs. Wilson seemed very interested in hearing a Clerks point of view on the issue and was open to discussing the issue. I believe that feedback from the group can be an influence on this issue and encourage you to add your voice to the discussion. The link to the audio of the hearing is:

I apologize for the delay in getting this information to you. Below are the responses sent by our Communication Officer David Martinson to [REDACTED].

I rewrote the response with more details, but the first version got posted before David received my version.

"We want to clarify what happened so you will understand.

We can assure you that this was not a case of voter fraud.

What happened was that an inconsequential mistake was made by the poll worker.

In creating the voter access card, the poll worker missed a step on the poll pad to select "create ballot style." By missing that step, a ballot style for your husband's precinct was not created for his voter access card.

When he inserted his card into the voting machine, instead of displaying a ballot, it was **blank**. (A ballot was not displayed so he could not have cast any votes!)

A blank voter access card causes a red **generic** default error to appear indicating, "This voter access card is already voted. Please remove it from the machine."

The poll worker called the Election Help Desk so the voter access card could be cleared and one recreated that would display a ballot so your husband could vote.

The poll workers you spoke to were referring to properly enabling the voter access card, which is a generic information transmitting device. Votes are not stored on a voter access card. The voter access card allows a voter's ballot to be shown on the touchscreen.

When votes are cast on an electronic voting machine, they **CANNOT** be cleared. There are three redundant memories of votes cast on the machine, on a paper trail, in an internal memory and on a memory card locked inside the machine."

Thank you again for providing us with your primary election canvass and audit materials. Attached is the candidate certification for the special general election. A few notes as you prepare ballots:

- **Straight Party Voting.** Because there is only one partisan race on the ballot, do not include straight party on the ballot.
- **Unaffiliated Candidates.** There is one unaffiliated candidate for CD3. The law states that unaffiliated candidates shall appear on the ballot "with a mark referencing the following statement at the bottom of the ticket: 'This candidate is not affiliated with, or does not qualify to be listed on the ballot as affiliated with, a political party.'" See 20A-6-301(1)(e).
- **Write-in Candidates.** There are write-in candidates for CD3, so you will need to provide a write-in space for CD3. Keep in mind that write-ins have until 5:00 pm on September 8, 2017 to declare candidacy for CD3, municipal offices, and special service districts as well. Our office will certify the list of CD3 write-in candidates shortly thereafter.
- **Ballot Propositions.** Municipalities have until Tuesday, September 5, 2017 to place a ballot proposition on the ballot.
- **UOCAVA Ballots.** These must be sent by Friday, September 22, 2017.
- **Canceling Municipal Elections.** If a municipality or special district's contests are unopposed and they do not have a ballot proposition, they may cancel their election. If this occurs, the county would simply administer the CD3 election for those precincts. See 20A-1-206.

Subject: HB 75 - Municipality Overreach

HB 75 is the bill that forces a County to administer their election, regardless of whether or not a County has confidence in the election method. Last Friday, it passed out of the Gov Ops committee unanimously. Ricky did a phenomenal job in his testimony. Unfortunately, multiple misrepresentations were made during testimony regarding county clerks and our position. The bill is on third reading in the House. HB75 Municipal Alternative Voting Methods Pilot will soon be coming up for vote on the house floor. Make no mistake, **this bill is not about ranked choice voting (RCV). It is about a political entity forcing another political entity to provide a service for them that is readily available through other means.** Regardless of your position on RCV, please do not force the counties to administer municipal elections. I am asking you to vote no on this bill.

If passed, HB75 would require Counties to provide a service on behalf of a city, if the city chooses to participate in the Alternative Voting Pilot Project.

The clerks have been and remain neutral on the pilot program. This bill is a governmental overreach and unnecessary because if a city wants to participate in the pilot project and conduct its elections using RCV, they can. Supporters of this bill will say that HB75 is necessary, they will say that the Counties are preventing cities from using RCV in their election, this is not true.
