For the Full back-up copy of 2020 General Election County Voter Rolls: A report does not exist that shows only those voters who were eligible in the November election; however, a list of all current registered voters may be obtained by filling out the attached form and submitting payment of \$150. The voter list will contain the data only for voters that you are qualified to receive (due to state privacy laws) and will not contain any voters who resided in Weber County as of November, but who have since moved outside Weber County (approximately 15% of the population moves each year), or who have otherwise since been removed (i.e., death, etc.).
