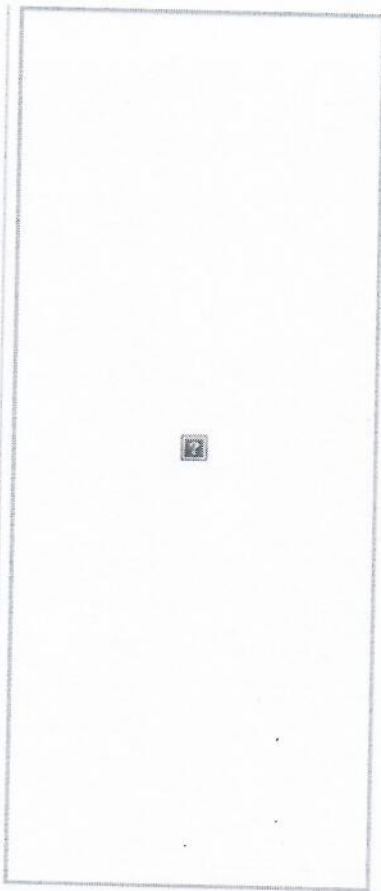

Good afternoon,

There seems to be confusion surrounding the withdrawal of [REDACTED], a former Democratic candidate for State Senate [REDACTED]. The Democratic Party may fill the candidate vacancy if the vacancy meets the requirement outlined in Utah Code 20A-1-501(1)(a)(ii)(B), which states that the candidate "resigns because of acquiring a physical or mental disability, certified by a physician [emphasis added], that prevents the candidate from continuing the candidacy."

Please note that Utah Code 58-67-102(16) defines "physician" as "both physicians and surgeons licensed under Section 58-67-301, Utah Medical Practice Act, and osteopathic physicians and surgeons licensed under Section 58-68-301, Utah Osteopathic Medical Practice Act." The definition of "physician" does not include "physicians assistant," and physicians assistants are licensed under a separate code section, Utah Code Title 58 Chapter 70a Part 3.

In order for any party to fill a candidate vacancy, the legal requirements set forth in 20A-1-501 must be met. Our office does not believe that any letters submitted to this point by [REDACTED] or medical professionals on [REDACTED] behalf, meet the requirements of 20A-1-501.

If a political party attempts to fill a candidate vacancy when legal requirements are not met, any candidate who declares candidacy for the vacancy could be challenged.

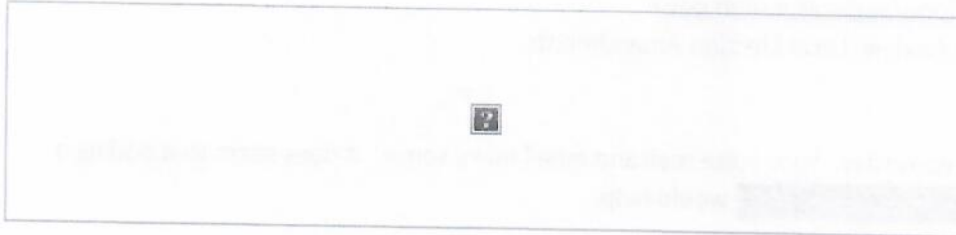




