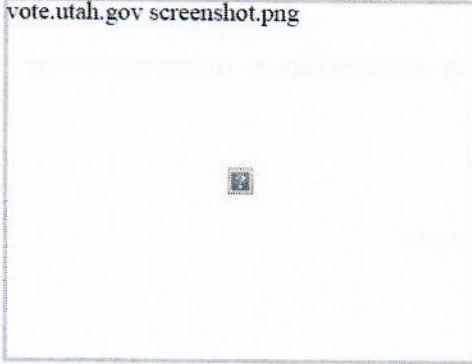

Hi Pam,

I believe I figured out the issue specific to [REDACTED]. The screenshot you provided lists the voter's birthdate as [REDACTED], but the website requires a four-digit year format (YYYY) instead of a two-digit format (YY). I was able to pull up his information using the YYYY format:

vote.utah.gov screenshot.png



When the voter enters the birth date, it prompts the DD/MM/YYYY format like so:

Birth Date.png



If this is causing too much confusion for the users, we will definitely look at making the date format prompt or error message easier to understand for future iterations of the website.

I apologize that you're getting a lot of phone calls and emails regarding the website. Do you have other specific issues that we can help with, or is your staff receiving calls and emails from voters who generally say that the website won't work?
