



Justin,

[REDACTED] registered to vote at the address of [REDACTED] [REDACTED] on [REDACTED]. He has not voted in any election at this address since he registered to vote. We sent him a confirmation notice in 2012 to verify he was still at the address listed above on July 27, 2012. The confirmation notice was returned and updated on October 3, 2012 and a new voter information card was mailed to [REDACTED] on October 7,



affiliation updated to UUP. After UI and DTS fixed the problem on July 13, 2017, there do not appear to be any other registration issues. Other than those seven voters, any voter who requested to have their party updated to UUP but is currently affiliated with another party, appears to have submitted a subsequent voter registration form.

When these issues were first brought to my attention I reached out to Salt Lake County to look at [REDACTED]'s record. Because we could see his voter registration form clearly indicated he wanted to affiliate with UUP, Salt Lake County immediately updated his record. The fix for the remaining six voters can be just as simple. Because we have forms on file for those voters showing their desire to affiliate UUP, their record will be updated accordingly. As we have also discussed, we will look into passing the voter more complete information regarding their voter registration once it is processed so any issue can be identified quickly.

The second voter registration issue is unique to [REDACTED]. On November 7, 2017 [REDACTED] voted using a provisional ballot. A provisional ballot form is used to update a voter's registration information. At that time he selected "unaffiliated" for his political party. On March 12, 2018 [REDACTED] filled out a voter registration form and designated his party affiliation as "United Utah." His party affiliation was updated in the system to UUP.

On March 26, 2018 Cache County was working through provisional ballot information and a temporary worker updated [REDACTED]'s voter registration using the information on the November 2017 provisional ballot registration. This was a mistake. I have attached a letter from Cache County explaining how this happened. Cache County has since updated [REDACTED]'s party affiliation to UUP.

Derek Brenchley from our office is sending you a response to your GRAMA request dated May 11, 2018.

I am more than happy to set up a meeting or a phone call to answer any questions or to explain any of the responsive documents included in the GRAMA request.

Thank you for bringing these issues to our attention.

He marked his party affiliation as United Utah Party on [REDACTED], but his affiliation is listed as Unaffiliated. I don't see any documents that show he changed anything after [REDACTED].

He recalls receiving something from you that says he was affiliated with UUP, but I'm not seeing anywhere in VISTA that records him as being UUP, just unaffiliated. I'm guessing there was some bug with the party right after we certified them, which would have been July 13.

It looks like he party affiliation should be updated to match his form.



Hi Sherrie,

The "Track My Ballot" option allows a voter to see if a ballot has been sent to them and determine if it has been received and/or counted by the county clerk. Here are the various statuses that voters may see on that page as well as the logic behind each status:

- NO\_BALLOT\_STATUS = "No Ballot Found." There is no ballot data generated for the voter (or the date of the election is 45+ days away).
- A\_BALLOT\_COUNTED = "Your mail ballot was counted." The ballot was counted (no data in XCOUNTREASON) and the date is Election Day and after.

The EAC website indicates that Salt Lake County does not use EAC accredited systems. Why is that? What are they using? If their systems are not accredited by the EAC, how is the Lt. Governor ensuring they meet the requirements in section 2a(ii)? Is the same method of certification used for Salt Lake County machines as is used in other counties? If not, how are Salt Lake County machines certified? Is a report available for their certification? If so, how can the public view this document?

I contacted the Lt. Governor's office a couple of weeks ago to ask where to find previous election audits. However, no one has responded to my inquiry. Perhaps you could help direct me? According to Verifiedvoting.org, they should be posted on the Lt. Governor's website, but I cannot locate them there. Could you tell me where they are posted for public viewing?

Finally, I have grave concerns about the voting systems we use in Utah for our elections. The attention these machines are finally getting nationally, has given me hope that we might finally address their vulnerability to outside influence. While the highly contested states have clearly shown there is reason to be concerned, other states are now finding reason to question their own vote counts. Just this past week New Hampshire found significant discrepancies in down ballot races after a hand count. A simple audit of these machines is not sufficient to find many of these problems. Facing the fact that there may be a problem with our machines is not a popular topic among our elected officials as it requires them to question the validity of their own contests and the possibility that they are not duly elected. How would you suggest Utah begin an honest inquiry into our voting systems to ensure that we truly have an election we can feel confident is accurate and safe from potential outside tampering?
