Dear County Clerks,

During the 2016 Legislative General Session the legislature passed H.B.21, Election Revisions. This bill requires that after election day, results be released each day up through the canvass for any absentee or provisional ballots counted on a given day. Election results only need to be released on days that ballots are counted but there is no requirement that ballots be counted every day.

We know that there are many things that have to be done after election day including gathering and processing election equipment and materials from polling locations, reconciling poll books and provisional ballots, processing by mail ballots and conducting an audit. We also understand that it is much more efficient to process ballots in large batches every few days than in small batches every day.

As this legislation was discussed at the Utah Association of Counties meeting on Friday, April 15 there seemed to be a consensus that the Lt. Governor's Office should provide guidelines to the county clerks that would set forth a unified schedule for counting and releasing election results. I have attached a draft of those guidelines. This will help our office as we try and manage the continual release of results, but more importantly will help the public, as they can expect when the election results will be released.

Before we set forth this guideline, we want to get your input on a proposed schedule. Keeping in mind the work that needs to be done in the days after the election and a desire to release results in a manner that will be consistent across the state we propose that after election day ballots be counted and results released on the Friday after election day, the following Tuesday, the following Friday and finally on Canvass Day.

For the 2016 Primary Election that means ballots would be counted and results released on:

Tuesday, June 28  
Friday, July 1  
Tuesday, July 5  
Friday, July 8  
Tuesday, July 12

Below is the ballot order as recorded in the database for [REDACTED]. I tried to phone her and you, but didn't get an answer. Her ballot was mailed to her on October 13<sup>th</sup>. Also included below, is the mail-tracking on her ballot (ID [REDACTED]). It shows her ballot went "out for delivery" with the carrier on October 14<sup>th</sup>. It should have arrived that day. Please have her check and see if she received it (bright yellow envelope).

I cannot look up other voters for whom you think ballots should have been delivered without their specific information. In looking at all the registered voters at that address, I see about fourteen listed as "inactive," and that would mean they weren't sent a ballot. We cannot mail ballots to "inactive" voters in accordance with Utah State Law.

I took the time to check into each record for about 120 voters registered there. About a dozen have not returned their ballots yet. One person didn't include an apartment number on the registration form ([REDACTED]) so her ballot may not have been delivered to her.

We can email ballots to voters who need an ADA accomodation.

Has the Lt. Governor's office responded to the complaint about 'Draper Residents Asking How Many Weeks are in This Election?' The complaint was sent to the LG and to the Salt Lake County Clerk.

This group does not appear to be registered as a PAC, although they seem to fit the description ("an entity, or any group of individuals or entities . . . a major purpose of which is to make expenditures or expressly advocate for any person . . . to vote . . . against any candidate or person seeking election to a municipal . . . office." UTAH CODE ANN. § 20A-11-101(34)(a)(ii) (2017)).

Salt Lake County's ordinance gives the County Clerk some authority to enforce the rules regarding PACs. But her power to impose penalties is not as great as those of the LG's under section 20A-11-603, UTAH CODE ANN. (2017). In particular, a PAC that violates the statute by failing to respond to a notice from the LG is guilty of a class B misdemeanor and liable to pay a civil fine of \$1,000. See UTAH CODE ANN. § 20A-11-603(4). Meanwhile, failing to respond to a similar notice from the county clerk under county ordinance is punishable only as an infraction. See section 2.72A.603(B) and (C), Salt Lake County Code of Ordinances, 2001.

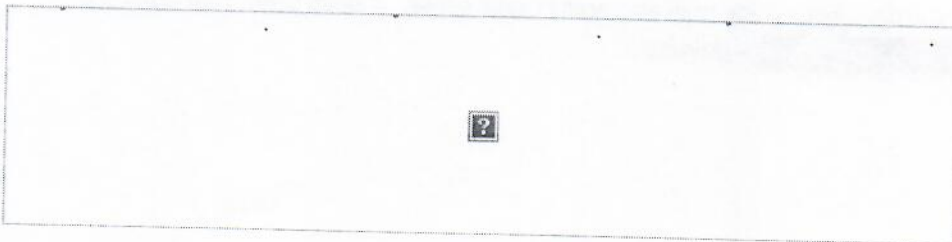

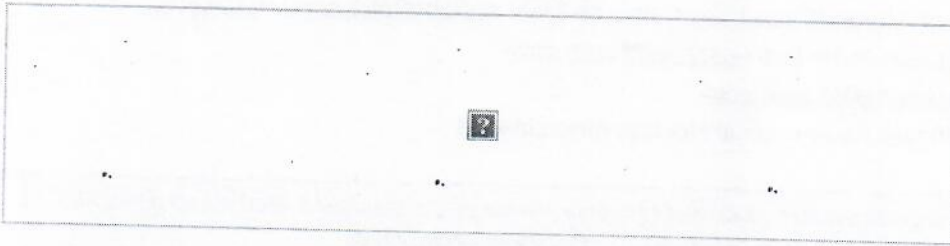
