Hello Mr. Lee,

A few weeks ago I contacted your office requesting assistance voting as a blind person after the Salt Lake County Clerk told me my only option to vote was to go to a physical polling location to use a talking machine (when no other citizen is forced to do this) or to sacrifice my right to a secret ballot by having a friend help me fill out the ballot. Both of these options are illegal, discriminatory, and unacceptable, especially since the technology and free federal money exist to solve this problem, and the clerk has known of this issue for years and refuses to do anything about it.

After I spent many days and weeks contacting multiple state and federal politicians, fighting for my right to vote, to resolve my issue, the clerk is sending someone to my home with a voting machine so I can cast a ballot from home in a equivalent matter to a sighted person voting by mail.

Q - Does this mean that candidates have to file remotely?

A - No. Candidates can still file in person.

Q - How does remote filing work?

A - See 20A-9-202(1)(c). Basically the candidate sends an agent with their paperwork, and the filing officer communicates with the candidates via some type of video communication. The agent cannot sign the declaration paperwork on the candidate's behalf.
