

Won by 233,012 votes





Roadblocks

Lack of Transparency

- Petition to Stop Certification Dropped
- 1st Amendment Issues
- Timely Access to Data
- Cast Vote Records
- Local Media Reporting
- Citizen Awareness

Results Reporting

- Results reporting process for the state is beyond the date of canvassing and the deadline date of filing an election contest; thus impossible to obtain a list of names of those who voted in an election that matches the number of people who voted. This makes it hard for candidates to effectively challenge any election.

Voter Registrations

- Same day voter registrations where someone can vouch for up to 8 other people. But in homeless shelter, nursing home, and transitional housing, the staff there can vouch for an unlimited number of people in their care.
- Election Day Registration = 259,742 (7%)

Elected Officials

- State level officials have so far been ineffective.
- Municipalities have the authority to make decisions on whether machines are used in the county.
- Unfortunately, local officials feel that they do not have the authority or lack courage to pass resolutions.
- Decision-making left to clerks who may not understand how elegant electronic election fraud is—can even occur without their knowledge.



Victories

Canvassing & Audits

- Canvassing began in Crow Wing and then replicated elsewhere
- Legislative Auditor is reviewing the evidence
- Forensic audit resolution in Crow Wing, denied by SOS

County Level

- County Commissioner Turnout on the Rise
- Drop Boxes Removed
- Party Balance at Absentee Ballot Boards and Election Judges
- Hand Tally Resolutions
- Cast Vote Records

MN Supreme Court

- A22-1081 filed on new systems; the MNSOS Office presented evidence contrary to the EAC and Vendor—plan to refile cases
