



## Reason for Hope



### Texas

- Texas DOES have a legal paper ballot voting system that **EVERY** county can adopt.
- We have Secretary of State confirmation that they stand at the ready to help counties adopt the only legal voting system left in Texas.
- Texans CAN perform comprehensive citizen audits of their election records via PIA requests. You can even request the email communications between election officials and voting system vendors!
- Texans have proven that the electronic voting systems are generating unknowable and unrecoverable election results when not using hand marked paper ballots in the voting precinct.
- Fortunately, thousands of Texans are using their time , talent, & treasure to investigate and help implement the only securable, auditable and legal voting system.



## Reason for Hope: Success



### Texas

- Since the 1800's, Texas has had a **SECURABLE, AUDITABLE, and ACCOUNTABLE** paper ballot voting system with hand-marked, hand-tallied, paper ballots in the small voting precinct.
- Texans are petitioning their County Commissioners courts to adopt the Ch. 65 Method of handmarked paper ballots, see [Tallytexas.org](http://Tallytexas.org) and sign up at [Causeofamerica.org](http://Causeofamerica.org)
- Counties and Cities are already using handmarked paper ballots in the voting precinct.
- Texans are practicing and learning how to tally using the only legal voting system we have left.
- The Texas Secretary of State has issued an opinion stating that all Texas counties can adopt the Chapter 65 method right now.
- Filed a criminal complaint with our DA and days later he was forced to resign!
